

**HILLTOWN TOWNSHIP
BUCKS COUNTY, PENNSYLVANIA
ORDINANCE NO. 2003- 3**

AN ORDINANCE REDUCING THE SPEED OF MOTOR VEHICLES ON MORGAN LANE (T-472) TO 25 M.P.H., REDUCING THE SPEED OF MOTOR VEHICLES ON VICTORIA LANE (T-473) TO 25 M.P.H. AND REDUCING THE SPEED OF MOTOR VEHICLES ON BRITTANY LANE (T-474) TO 25 M.P.H.

THE HILLTOWN TOWNSHIP BOARD OF SUPERVISORS, upon recommendation of the Hilltown Township Police Department who have observed the traffic patterns on Morgan Lane, Victoria Lane and Brittany Lane within Hilltown Township, Bucks County, Pennsylvania, and pursuant to appropriate engineering and traffic studies and investigations, hereby enacts and ordains as follows:

SECTION 1. Words and phrases when used in this Ordinance shall have the meaning described to them in the Pennsylvania Motor Vehicle Code "P.M.V.C.", 1976, June 17, P.L. 162, Act Number 8a, as amended. (75 P.S. 1000 et seq. as now enforced or hereafter amended).

SECTION 2. Maximum Speed Limits Hereby Enacted -- Maximum speed limits are hereby established on the herein-specified streets as follows, and it shall be unlawful for any person to drive a motor vehicle, on any part of said street or road where a maximum speed limit applies, at a higher speed than the maximum prescribed for that part of the street or road:

<u>Street</u>	<u>Between</u>	<u>Maximum Speed Limit</u>
Morgan Lane (T-472)	Entire Length	25 M.P.H.
Victoria Lane (T-473)	Entire Length	25 M.P.H.
Brittany Lane (T-474)	Entire Length	25 M.P.H.

SECTION 3. The proper authorities of the Township are directed to erect official signs reducing the speed on the aforesaid Morgan Lane, Victoria Lane and Brittany Lane as set forth herein, and to do so in conformity with the provisions of the P.M.V.C.

SECTION 4. Any person violating the maximum speed limit as set forth herein shall be prosecuted under the P.M.V.C., and shall be subject to the fines and penalties therein set forth.

SECTION 5. All Ordinances, parts of Ordinances, and amendments thereof are repealed insofar as they are inconsistent with the foregoing Ordinance.
