ORDINANCE NO. 2002- 2

AN ORDINANCE REDUCING THE SPEED OF MOTOR VEHICLES ON HIGHVIEW ROAD (T-405) TO 35 M.P.H.; REDUCING THE SPEED OF MOTOR VEHICLES ON MARON ROAD (T-418) TO 35 M.P.H.; ~~REDUCING THE SPEED OF MOTOR VEHICLES ON FAIRHILL SCHOOL ROAD (T-401) TO 45 M.P.H.~~; REDUCING THE SPEED OF MOTOR VEHICLES ON AUDREY LANE (T-449) TO 25 M.P.H.; REDUCING THE SPEED OF MOTOR VEHICLES ON BEVERLY ROAD (T-450) TO 25 M.P.H.; AND TO REDUCE THE SPEED OF MOTOR VEHICLES ON CENTRAL AVENUE (T-403) TO 35 M.P.H. FROM ITS INTERSECTION WITH BETHLEHEM PIKE (SR-4085) TO ROSEWOOD DRIVE (T-477) AND TO REDUCE THE SPEED OF MOTOR VEHICLES ON CENTRAL AVENUE (T-403) TO 25 M.P.H. FOR THAT PORTION OF SAID CENTRAL AVENUE FROM ROSEWOOD DRIVE (T-477) TO THE TELFORD BOROUGH BOUNDARY LINE WITH HILLTOWN TOWNSHIP AND/OR COUNTY LINE ROAD (SL-4027).

THE HILLTOWN TOWNSHIP BOARD OF SUPERVISORS, upon recommendation of the Hilltown Township Police Department who have observed the traffic patterns on Highview Road, Maron Road, ~~Fairhill School Road~~, Central Avenue, Audrey Lane and Beverly Road within Hilltown Township, Bucks County, Pennsylvania, and pursuant to appropriate engineering and traffic studies and investigations, hereby enacts and ordains as follows:

SECTION 1. Words and phrases when used in this Ordinance shall have the meaning described to them in the Pennsylvania Motor Vehicle Code "P.M.V.C.", 1976, June 17, P.L. 162, Act Number 8a, as amended. (75 P.S. 1000 et seq. as now enforced or hereafter amended).

SECTION 2. Maximum Speed Limits Hereby Enacted -- Maximum speed limits are hereby established on the herein-specified streets as follows, and it shall be unlawful for any person to drive a motor vehicle, on any part of said street or road where a maximum speed limit applies, at a higher speed than the maximum prescribed for that part of the street or road:

Highview Road (T-405)	Entire Length	35 M.P.H.
Maron Road (T-418)	Entire Length	35 M.P.H.
Fairhill School Road (T-401)	Entire Length	45 M.P.H.
Audrey Lane (T-449)	Entire Length	25 M.P.H.
Beverly Road ((T-450)	Entire ength	25 M.P.H.
Central Avenue (T-403)	Bethlehem Pike (SR-4085) and Rosewood Drive (T-477)	35 M.P.H.
Central Avenue (T-403)	Rosewood Drive (T-477) and Telford Borough Boundary Line and/or County Line Road (SL-4027)	25 M.P.H.

SECTION 3. The proper authorities of the Township are directed to erect official signs reducing the speed on the aforesaid Highview Road, Maron Road, Fairhill School Road, Central Avenue, Audrey Lane and Beverly Road as set forth herein, and to do so in conformity with the provisions of the P.M.V.C.

SECTION 4. Any person violating the inaximum speed limit as set forth herein shall be prosecuted under the P.M.V.C., and shall be subject to the fines and penalties therein set forth.

SECTION 5. All Ordinances, parts of Ordinances, and amendments thereof are repealed insofar as they are inconsistent with the foregoing Ordinance.
