



ORDINANCE #99-8
HILLTOWN TOWNSHIP
BUCKS COUNTY, PENNSYLVANIA

AN ORDINANCE REDUCING THE SPEED OF MOTOR VEHICLES ON SCHULTZ ROAD, AND BRINKLEY AND BRIARWOOD DRIVES; AND ESTABLISHING NO PARKING ON THE SOUTH SIDE OF SCHULTZ ROAD.

THE HILLTOWN TOWNSHIP BOARD OF SUPERVISORS, upon recommendation of the Hilltown Township Police Department who have observed the traffic patterns on Schultz Road, Brinkley Drive and Briarwood Drive within Hilltown Township, Bucks County, Pennsylvania, and pursuant to appropriate engineering and traffic studies and investigation, hereby enacts and ordains as follows:

Section 1. Words and phrases when used in this Ordinance shall have the meaning described to them in the Pennsylvania Motor Vehicle Code "P.M.V.C.," 1976, June 17, P.L. 162 Act Number 8a, as amended (75 P.S. 1000 et. Seq., as now enforced or hereafter amended).

Section 2. The operation of any motor vehicle in excess of thirty-five (35) miles per hour on Schultz Road, for its entire length in Hilltown Township is hereby prohibited.

Section 3. The operation of any motor vehicle in excess of twenty-five (25) miles per hour on Brinkley Drive and Briarwood Drive, for their entire lengths in Hilltown Township is hereby prohibited.

Section 4. Parking on the south side of Schultz Road, for its entire length in Hilltown Township is hereby prohibited.

Section 5. The proper authorities of the Township are directed to erect official signs reducing the speed limits of the aforesaid Schultz Road, Brinkley Drive, and Briarwood Drive as set forth herein, and to do so in conformity with the provisions of the P.M.V.C.; and to establish no parking on the south side of Schultz Road as set forth herein, and to do so in conformity with the provisions of the P.M.V.C..

Section 6. Any person violating the maximum speed limits as set forth herein shall be prosecuted under the P.M.V.C., and shall be subject to the fines and penalties therein set forth; and any person violating the restriction of parking on the south side of Schultz Road as set forth herein shall be prosecuted under the P.M.V.C., and shall be subject to the fines and penalties therein set forth.

Section 7. All Ordinances, parts of Ordinances, and amendments thereof are repealed insofar as they are inconsistent with this Ordinance.

Section 8. This Ordinance shall become effective five (5) days after final enactment.
