

ORDINANCE NO. 93-4

AN ORDINANCE OF THE TOWNSHIP OF HILLTOWN,  
BUCKS COUNTY, REPEALING ORDINANCE NO. 92-2,  
CLARIFYING THE RIGHTS AND OBLIGATIONS OF  
ALL AUTHORITIES PROVIDING WATER SERVICE  
UNDER THE MUNICIPALITY AUTHORITIES ACT  
OF 1945, AS AMENDED, AND CLARIFYING THE  
EXCLUSIVE SERVICE AREA OF TELFORD BOROUGH  
AUTHORITY WITHIN HILLTOWN TOWNSHIP.

Preamble

Pursuant to Section 702 of the Second Class Township Code and the Municipality Authorities Act of 1945, the Board of Supervisors of Hilltown Township hereby enacts and ordains as follows:

SECTION I - PURPOSE

This Ordinance is designed to repeal the exclusivity of water service provisions contained in Ordinance No. 68-1 whereby Sellersville Borough, Perkasio Borough Authority and Telford Borough Authority were granted exclusive rights of public water service within Hilltown Township. This Ordinance is further designed to recognize all municipal authorities providing public water service within Hilltown Township which are properly organized under the Municipality Authorities Act of 1945, 53 P.S. 301 et seq. as hereafter amended by the General Assembly of Pennsylvania, and to clarify the exclusive public water service area within Hilltown Township of the Telford Borough Authority.

SECTION II - PRIORITY OF PUBLIC WATER SYSTEMS

A. The Hilltown Township Water and Sewer Authority shall have priority in providing public water service to those areas of the Township within which it can reasonably and economically extend such water service to Township residents except that the Telford Borough Authority shall have exclusive water service rights in an area of Hilltown Township known as "Water Region I" as set forth in an Agreement dated September 3, 1993 between Hilltown Township, Hilltown Township Water and Sewer Authority and Telford Borough Authority.

B. All municipal authorities operating within the corporate boundaries of Hilltown Township who intend to construct, extend or abandon any water line may do so upon written notice to the Township.

SECTION III - REPEALER

All ordinances or parts of ordinances which are inconsistent herewith are hereby repealed. Specifically, Ordinance No. 92-2 is hereby repealed.

SECTION IV - EFFECTIVE DATE

This Ordinance shall become effective five (5) days after adoption.
