

**ORDINANCE NO. 90-4**

**AN ORDINANCE OF THE TOWNSHIP OF HILLTOWN  
REGULATING THE PARKING OF MOTOR VEHICLES  
WITHIN HILLTOWN TOWNSHIP**

**PREAMBLE**

The Hilltown Township Board of Supervisors, upon recommendation of the Hilltown Township Police Department, hereby enacts and ordains the following Ordinance regulating the parking of motor vehicles on certain roads within Hilltown Township, based upon the finding and purpose that certain areas of Hilltown Township are subjected to commuter vehicle parking which affects the efficient movement of traffic and also subjects such roads and streets to a degree of commuter traffic which substantially reduces the quality of the ambient air level.

**SECTION ONE**

Parking is hereby prohibited on Reliance Road on both sides of that portion of said road between Township Line Road and Washington Avenue.

**SECTION TWO**

Parking is hereby prohibited on Central Avenue on both sides for that portion of said road eastward from the Telford Borough boundary for 1,500 feet.

**SECTION THREE**

Parking is hereby prohibited on Route 309 on the northern side for that portion of said road between Church Road north to the Route 309 Bypass Limited Spur Exit.

**SECTION FOUR**

Parking is hereby prohibited on Route 113 on both sides for that portion of said road between County Line Road to the 309 Bypass Intersection.

**SECTION FIVE**

Parking is hereby prohibited on Pleasant Spring Lane on both sides of said street.

## SECTION SIX

Parking is hereby prohibited on Conestoga Way on both sides for that portion of the road between the narrowing of Green Meadows, Section III, and Telford Homes, formerly Green Meadows, Section IV, and its intersection with East Summit Street. It shall further be unlawful for any person to park or permit any vehicle in his or her control to be parked upon Conestoga Way for that portion of the roadway between its intersection with Reliance Road and the boundary of Green Meadows, Section III, with the Subdivision known as Telford Homes, formerly Green Meadows, Section IV.

## SECTION SEVEN - SIGNS

The proper authorities of the Township are hereby directed to erect official signs restricting parking as aforesaid as required and in conformity with the provisions of the Motor Vehicle Code.

## SECTION EIGHT - PENALTIES

Any person, firm, corporation, partnership or entity who violates any provision of this Ordinance shall, upon conviction, be sentenced to pay a fine of not more than Twenty-Five (\$25.00) Dollars plus costs. Provided: It shall be the duty of the Township Police Department or other designated person to report all violations of any provision of this Ordinance, indicating the section violated, license number of the vehicle involved in the violation, the location where the violation took place, and any other facts that might be necessary in order to secure a clear understanding of the circumstances attending the violation.

## SECTION NINE - REPEAL

Previous ordinances of Hilltown Township inconsistent herewith are hereby repealed, and superseded herein.

## SECTION TEN - EFFECTIVE DATE

This Ordinance shall be effective five (5) days after adoption.
