

ORDINANCE NO. 82-7

AN ORDINANCE REGULATING AND RESTRICTING THE SPEED OF MOTOR VEHICLES ON CONESTOGA WAY BETWEEN THE INTERSECTION OF RELIANCE ROAD AND EAST SUMMIT STREET; AND AN ORDINANCE REGULATING PARKING ON CONESTOGA WAY AT THE SAME POINT.

BE IT ENACTED AND ORDAINED by the Board of Supervisors of the Township of Hilltown, County of Bucks and Commonwealth of Pennsylvania, and it is hereby enacted and ordained by the authority of the same as follows:

SECTION 1. Words and phrases when used in this ordinance shall have the same meaning ascribed to them in the Vehicle Code of Pennsylvania, as now in force, or as hereafter amended.

SECTION 2. The operation of any motor vehicle in excess of twenty-five (25) miles per hour on Conestoga Way, Township Road No. _____, between the intersection of Reliance Road (T404) and East Summit Street (T427B) is hereby prohibited.

SECTION 3. The proper authorities of the Township are hereby directed to erect official signs restricting the speed as aforesaid in conformity with the provisions of The Vehicle Code.

SECTION 4. Any person violating the maximum speed limit as set forth in Section 2 hereof shall be prosecuted under the

pertinent section of the Vehicle Code, Act of June 17, 1976 P.L. 162, as amended, and shall be subject to the fines and penalties therein set forth.

SECTION 5. It shall be unlawful for any person to park or permit any vehicle in his control to be parked upon Conestoga Way for that portion of the roadway between its intersection with Reliance Road (T-404) and the boundary of Green Meadows, Section III, with the Subdivision known as Telford Homes, formerly Green Meadows, Section IV. Parking shall be prohibited on both sides of Conestoga Way for that portion of the roadway between the boundary of Green Meadows, Section III, and Telford Homes, formerly Green Meadows, Section IV, and its intersection with East Summit Street (T-427B).

SECTION 6. The proper authorities of the township are hereby directed to erect official signs restricting parking as aforesaid as required and in conformity with the provisions of The Vehicle Code.

SECTION 7. Any person violating the provisions of this ordinance relating to parking shall, upon conviction thereof in a summary proceeding, be sentenced to pay a fine not exceeding Ten Dollars (\$10.00) and in default of such fine to undergo imprisonment for a period not exceeding five days.

SECTION 8. This ordinance shall become effective five

(5) days after final enactment.
