

ORDINANCE NO. 87-1

AN ORDINANCE AMENDING ORDINANCE NO. 78-7, WHICH PRIOR ORDINANCE PROVIDED FOR THE PROPER MAINTENANCE, INSTALLATION, ALTERATION, CONSTRUCTION AND SERVICING OF ELECTRICAL SYSTEMS AND THE ADOPTING OF THE NFPA NATIONAL ELECTRICAL CODE, AND THE PRESENT ORDINANCE AMENDS THAT ORDINANCE BY ADDING PROVISIONS PROVIDING FOR INSPECTIONS AND TESTS

BE IT ORDAINED AND ENACTED, by the Board of Supervisors of Hilltown Township of Bucks County, Pennsylvania, and it is hereby enacted and ordained by authority of the same:

Section 1. This ordinance amends Section II. Article 90-4 b. Inspections, by deleting that section and replacing it as follows:

b. Inspections and Tests:

1. Inspections and tests to determine whether the provisions of the National Electrical Code and this ordinance have been complied with shall be by one of the following approved inspection agencies: ATLANTIC-INLAND, INC., MIDDLE DEPARTMENT INSPECTION AGENCY, INC., or MIDDLE-ATLANTIC ELECTRICAL INSPECTIONS, INC., which agencies are the approved inspecting agencies for inspections for the Township. Upon completion of any electrical work, where inspections or tests are required to be done under this ordinance and to be completed by an approved inspecting agency, a Certificate of Inspection and Approval issued by such inspection agency shall be furnished to the Township Electrical Inspector

not later than fifteen (15) days after completion of the installation of the electrical work. Schedules of the fees charged by the authorized inspecting agencies shall at all times be kept on file in the office of the Electrical Inspector and open to public inspection.

2. All decisions as to whether or not electrical work complies with the provisions of the National Electrical Code and this Ordinance shall be made by the Electrical Inspector who is hereby authorized to stop any electrical work in process and order the removal thereof if he shall determine that such work is not being installed in conformity with the provisions of the National Electrical Code and this Ordinance.

3. The Electrical Inspector is hereby authorized to waive inspection of a portion of or all electrical work for which he shall have received a duplicate record of approval from one of the approved inspecting agencies, certifying that such work complies with the provisions of the National Electrical Code and this Ordinance. Notice of such waiver of inspection shall be given to the applicant so that the approved work can thereafter be concealed.

4. The Electrical Inspector shall not accept any Certificate of Inspection from an inspecting agency which has not been approved by the Hilltown Township Supervisors.
