ORDINANCE NO. 75-7

APPROVING FORM OF AGREEMENT PROVIDING FOR
TRANSPORTATION OF SANITARY SEWAGE AND INDUS-
TRIAL WASTES COLLECTED BY TOWNSHIP'S SANITARY
SEWAGE COLLECTION SYSTEM; AUTHORIZING EXECU-
TION OF AGREEMENT; AND REPEALING INCONSISTENT
ORDINANCES

WHEREAS, Hilltown Township, Bucks County, Pennsylvania (the "Township"), has undertaken a project to construct a sanitary sewage collection system and all appurtenant facilities in portions of the Township (the "Sewer System") and ultimately will require transportation (by means other than now included in the Sewer System plans and specifications) of sanitary sewage and industrial wastes collected by the Sewer System to a treatment facility for treatment and disposal; and

WHEREAS, Pennridge Wastewater Treatment Authority, Bucks County, Pennsylvania (the "Treatment Authority"), intends to construct an interceptor or trunk sewer, including metering stations and appurtenances (the "South Side Interceptor"), for the purpose of transporting sanitary sewage and industrial wastes emanating from the sewage collection facilities of the Township, Township of East Rockhill, Perkasio Borough Authority, Borough of Sellersville, Telford Borough Authority and Silverdale Borough (all collectively the "Collecting Agencies") for treatment and disposal in accordance with a Treatment Agreement dated as of November 1, 1975, at the wastewater treatment plant (the "Treatment Plant") hereafter to be acquired, modified and improved by the Treatment Authority; and

WHEREAS, the Township Board of Supervisors deems it to the mutual interest of the Township, the other Collecting Agencies and the Treatment Authority to approve and execute an agreement (the "Transportation

Agreement") providing for the transportation of sanitary sewage and industrial wastes collected by the Sewer System and by the collection facilities of the other Collecting Agencies to the Treatment Plant for treatment and disposal;

NOW, THEREFORE, BE IT ENACTED AND ORDAINED by the Board of Supervisors as follows:

1. The form of Transportation Agreement dated as of November 1, 1975, between and among the Township, the other Collecting Agencies and the Treatment Authority providing for the transportation of sanitary sewage and industrial wastes collected by the Sewer System and the sewage collection facilities of the other Collecting Agencies for treatment and disposal at the Treatment Plant is hereby approved in substantially the form presented at this meeting.
2. The Chairman of the Board of Supervisors is hereby authorized and directed to execute the Transportation Agreement and the Secretary of the Township to attest the corporate seal of the Township which shall be affixed thereto.
3. All ordinances or parts of ordinances heretofore adopted to the extent that the same are inconsistent in any manner herewith are hereby repealed.
