## A. <u>ANNOUNCEMENTS:</u>

#### F. ZONING HEARING BOAD ADVISORIES:

1. Bonnie Barnes – 618 Orchard Road – Proposes construction of a 16 ft. by 21 ½ ft. residential addition which results in a net increase of approximately 128 sq. ft. of impervious surface

After discussion, the Board directed Mr. Wert to speak with Mr. Taylor and Solicitor Grabowski about the feasibility of the Board to waive the requirement for the applicant to apply for a variance for such a minimal amount of additional impervious surface.

- 1. Supervisor Salvadore commended the Blooming Glen Garden Club for the fine job they have done with landscaping the former Municipal Building. Mr. Wert noted that the Garden Club is seeking a letter of support from the Board of Supervisors so that they can solicit donations from area businesses. The Supervisors were agreeable, suggesting Mr. Wert draft a letter for review by the Solicitor and the Board.
