The Supervisors of Holliston held their monthly meeting this day with all members present, passed and paid the following bills amounting to \$773.36. Receipts amounted to \$317.84. Bal in the Treasury \$5027.73. The Board passed a resolution transferring bal of State Funds of 1939 from maintenance for construction to be used with the 1940 State Appropriation for building road no 340. A report was sent to the state and also construction application. The 1940 budget was unanimously adopted amounting to \$21,619.00 with an unappropriated bal of \$156.25. The letter of resignation of Lloyd Gode, auditor was received and approved. The tax duplicate for street light tax with <sup>collectors</sup> warrant were given to collector. Abram K. Gode was assigned to meet the first meeting in April. Receipts
