#### HILLTOWN TOWNSHIP SUPERVISORS\* MEETING November 26, 1984

The meeting of the Hilltown Township Board of Supervisors was called to order by the Chairman, Mr. Vincent Pischl, at 7:30 P.M.

- A. <u>APPROVAL OF MINUTES</u>: Motion was made by Mr. Grunmeier to approve the previous meeting's minutes (11/12/84) as submitted; seconded by Mrs. Lockard and carried unanimously.
- B. TREASURER'S REPORT: In Mr. Wynn's absence, the Treasurer's Report was read by Mrs. Neiman; motion was made by Mrs. Lockard to approve the report as given, seconded by Mr. Grunmeier and carried unanimously.
- C. ACCOUNTS PAYABLE: Additional bill included in total bills presented for approval Bruce Nicholl Motors #410.332 \$550.00 to be paid 12/6/84. Motion was made by Mrs. Lockard to pay bills totalling \$12,934.47 when due, seconded by Mr. Grunmeier and carried unanimously.

  - (1) Old Business:

# F. PLANNING REPORT: (read by Mrs. Neiman)

(1) Creciun Site Plan - Plan has been recommended for approval by the Planning Commission. The Board tabled same until receipt of input from BCHD and PennDOT

### G. SOLICITOR'S REPORT:

- (1) East Rockhill/Hilltown Police Agreement Hilltown Township and East Rockhill are contemplating situation where George Egly, Chief of Hilltown Police Dept., would also serve as Chief of Police for East Rockhill. Mr. Drake requested additional time to review insurance requirements; the Board tabled discussion of same until next meeting (12/10/84).
- (2) Mr. Drake announced he would attend the next Supervisors' meeting of December 10, 1984, rather than the second meetin of the month.
- (3) Dedication of Right-of-Way Valentine B. Lee, Jr. Motion was made by Mrs. Lockard to adopt Resolution #84-45, dedicating right-of-way of Rickert Road to Township; seconded by Mr. Grunmeier and carried unanimously.
- (4) Motion was made by Mr. Grunmeier to adopt Resolution #84-46
  Dedication of Diamond Street and Schultz Road Robert
  Johnson Subdivision; motion seconded by Mrs. Lockard and carried unanimously.
- (5) Yothers Subdivision Mr. Drake reported he sent Deed of Dedication of right-of-way to Mr. Yothers; to date, has had no reply.
- (6) William Bennett Subdivision Nothing received to date from Mr. Bennett's engineer, Brian Nixon.
- (7) Revenue & Tax Anticipation Notes First meeting will be held January 2, 1985 regarding Northern Sewer District and Tax Anticipation Note.
- (8) Woodlawn Meadows' Street Light Litigation Mr. Drake reported the lights will be removed as of Jan. 1, 1985 and poles will be removed shortly thereafter. Mr. Grunmeie voiced his opposition to this settlement.

- (2) Mr. Pischl announced change of second December meeting to Tuesday, December 18th motion was made by Mrs. Lockard to change the second regularly scheduled Supervisors' meeting to Tuesday, December 18th (instead of Monday, Dec. 24th, due to holiday observance); motion was seconded by Mr. Grunmeier and carried unanimously. Advertisement will be placed in local newspaper.

8:01 P.M. Telford Industrial Development Authority Hearing called to order. Present were Stanford Hunn, Solicitor for Telford Industrial Development Authority; Mike and Wally Rosenthal; and Norman Mitman, Attorney for the Rosenthals. Mr. Hunn explained that the Rosenthal family (owners of Curtis Furniture) is seeking approval of the acquisition, construction and financing of a development project to be situate Northeast Corner Swartley Road and Route 309 (Line Lexington Lumber property). The maximum face amount of obligations to be issued not to exceed \$1,100,000.00. Time frame for most of rough work on shell - June 1985.

Motion was made by Mrs. Lockard to adopt Resolution #84-47, approving the development project of Telford Ind. Dev. Authority and J.R. Associates (Rosenthal family - name may be changed slightly) motion was seconded by Mr. Pischl. Mr. Grunmeier abstained from voting due to his involvement with the Telford Ind. Dev. Authority.
