The Supervisors of Hilltown held their Annual Meeting this day with all members present. Passed & paid the following bills amounting to \$3196.58. Receipts amounted to \$770.04, leaving a Bal in Gen Fund of \$24823.62. Mr. Shidell and Mr. Brehnen were present to inquire about putting a macadam on Chimp road along their premises. The Sec. was requested to adv. in news paper the time and place of 1958 Supervisors ^{meetings} open to the public and place at the Blooming Glen Hotel on the first Saturday of each month at 8 A.M. And also adv. that a \$5 Per Capita Tax is levied on all tax payers no change from 1957. (The Real Estate tax was not decided upon.) The organization of the new Board resulted as follows and elected Albert Agin Pres. Paul Frankenfield V. Pres. and appointed Abram N. Gother Sec. Treas. for the year 1958. The new Board decided to meet at the same place. And raised the wages of labor as follows Foreman Wm. H. Nice was ^{foreman} appointed ^{and a} wage raise from \$1.00 to \$2.00 per hr. Operators from \$1.50 to \$1.75 per hr. and common labor from \$1.40 to \$1.60 per hr. The Sec. was requested to withhold a check of \$5098.00 for General Electric until installation of Police Radio is satisfactory. The meeting adjourned to meet with the Auditors of the Township on Saturday Jan. 11. at which time a budget will be made up for inspection of the Tax payers of the Township of Hilltown. The secretary's pay for making Tax duplicate from \$100.00 to \$100.00 subject to approval by the Auditors. approved by the auditors on Jan. 11.
