The sec. was suggested to put an ad in the news Herald to advise the public of time & place of Super. meetings in 1960, namely the first and third Sat. of each month, at the Sup. Office at 9 A.M. and notify the audience to meet with the Super. at the Office on Jan 9, 1960, at 9 A.M. The bid for a used Proctor ^{Bonhag & Greenbacker} rec'd on Dec 5 was let this day to Howard H. Smartly at a price of 1644.00. Bal in the treasury at end of meeting was \$ 21458.77 in Gen Fund and \$ 5208.42 or a total of \$ 26667.19. The meeting adjourned to meet on Jan 2, 1960 for their annual meeting and organization of a new board for the yr. 1960.
