Mr High absent

The Supervisor of Hilltown held their semi-monthly meeting this day with two members present, passed and Paid the foregoing bills amounting to \$2218.51. Mr. High was not present on account of ill health. Mr. Berry was present to inquire as to how long 2 trailer coaches parked on his property were allowed to remain there. The Board directed him, (Mr. Berry) to have them vacated <sup>his property</sup> on or before April 1, 1960. Mr. Darrach <sup>a taxpayer</sup> was present to inquire why his lots of 120 ft frontage, already surveyed must now be changed to have 145 foot frontage, because not properly recorded in the County now comes under zoning restrictions. Mr. Magin also was informed his lots mapped out here too small under zoning jurisdiction & specifications. All newly members recently appointed were present to have both Officers Oath & Fidelity Oaths executed by Mr Paul Goder J. P. They were appointed to fill vacancies on Planning Com. and Zoning Officer & Zoning Board of adjustments a Mr Frank Smith, a representative of the Doylestown Agricultural Co was present and received a Form to present a bid on a Tractor with Backhoe & Front Loader. Said bids to be let on Dec 5 meeting by Board of Supr. at 10:00 A.M. The Board of Supr. by resolution set a price of \$5.00 for permits for additions to buildings and \$20.00 on new buildings. By resolution a committee of 5 were appointed to serve as ad. Dup Industrial Committee.

The meeting adjourned with a bal in the Gen. Fund of 17414.76 and in State Fund of \$5577.96, or a total Bal. of \$22992.72 to meet on Dec 5 1959 at Trng Office, at 9 A.M.

The Donald Barth plan no 24B-M 5823, upon motion by Mr Magin and seconded by Paul Frabur was this day passed finally.
