Lyle Hought were present and present to the board a map for constn. of a number of houses on Mr Hewitts property on Mill Rd. No decision as to building said houses was reached but is now being studied for later. A resolution was made to have 500 zoning Ordinances + map of same to be printed in book form for convenience of Tax payers who wish to get one at approximately .75 per book. A motion was made by Mr Agin and seconded by Mr Frankenburg to install a private phone in the Twp Building. Three men were appointed for zoning Board adjustments. They are Ernest S. Meyer of Blooming Glen, Henry J. Rice of Tel Rd and John Murphy of Halltown to serve as follows Murphy to Jan 1 1960, Rice to Jan 1 1961 and Meyer to Jan 1 1962. Mrs Herman Peters was appointed to zoning Officer at \$1.75 per hour of service rendered. Appointments for planning Com. Mr Carl Brunner, to take John Murphy's place on John Solliday to take place of Herman Peters. A motion was made by Paul Frankenburg and seconded by Mr Agin to authorize funds to purchase a tractor ^{with} ^{trailer} ^{and} ^{front} loader. The meeting adjourned to meet on Dec 5 1959 at The Twp Office at 9 A.M.
