The Supervisors of Hilltown held this semi monthly meeting this day with all members present, passed + paid the foregoing bills amounting to \$205.16 from Temp Fund and 3026.75 from State Fund or a total of 4232.91. Mr. James Moyer, Mrs. M. Moyer, Mr. & Mrs. Pinklett were present to bring complaint against the land fill operated in their community. A motion was made by Mr. Agin to appoint Mr. Harold Moyer of Dilweddale as member of Prop Planning Com. for a period of 1 yr. Bal. in Treasury at close of meeting was 19,342.67 in Temp Fund and 11,440.66 in State Fund or a total of 30,783.33. The meeting adjourned to meet on Sept. 19, 1959. The Sec. was authorized to prepare tax duplicate for street lights in Temp for collection in Nov. 1959 including 1960 taxes. P.S.
