Mr Scheidell + Mikelson were present with a committee from Skunk Hollow Rd + vicinity to forest condition along said road as to dust + bridges + opening of ditches + other nuisances. An Ordinance was ~~proposed~~ <sup>proposed</sup> to regulate Junk Yards in the Twp and require permits at a cost of \$100.00 per year to be paid to the Twp. Mr. Mowbray the Twp solicitor was present to discuss nuisance + other ordinances for the benefit of the Twp. Tax Payers Mr. Wm D. Rittell was also present and presented a bill to be paid to Mr. M. Conner for part payment of Bridges under Copots on Rd 421. The meeting adjourned with a bal. in the Gen Fund of \$19,485.76 and \$18,946.28 in State Fund or a total of \$38,432.04 to meet on July 18, 1959.
