The Supervisors of Hilltown held their semi-monthly meeting this day with all members present. Passed and paid the foregoing bills on pag 11. Amounting to 1975.88. Receipts amounted to 191.68. Mr. Montgomery Twp Solicitor and Mr. Ritchie Twp Engineer were present in respect to opening and reading of Bids. To be opened and read at 10. A.M. for construction of 2 span Reinforced Concrete bridges on Rd. No 421. Two bids were not opened because of arriving too late, namely at 10.30 A.M. Bids read and opened. The low bid was received from The M + M Constr. Co Inc of Stroudsburg Pa. amounting to 8161.00 To be let or rejected on May 2 meeting of Superior County aid forms were sent to Berks Co Commissioners by Mr. Ritchie requesting 50% of cost of bridges. The Board of Supervisors requested the secretary to inform P. P. & L. Co to prepare a contract to be signed on Apr 18 meeting for street lights Constr on 113 between Rt 309 and Souderstown Boro. of ten lights of 2500 lumens at a cost of 3.30 per light per month in terms of taxpayers petition. The meeting adjourned to meet on Apr 18 - at 9 A.M. The Dublin + Saltsdale Fire Co. were requested to (Abram K. Gother's Sec. furnish duly signed contracts to the Twp of Hilltown Twp for 1/8 of The Foreign Fire Ins tax received by Hilltown Twp in 1959. Applications for Constr were sent to Penna Highway Dept for approval of 2.6 mi 16 ft wide at estimated cost of 35,500.00. 96% of Motor Fund allocation was received on Apr 11 from State Highway Dept amounting to 19,838.81. Bal in the Treasury as 7225.00 in Gen Fund and 24091.45 in State Fund on a Total of 31316.45. County Aid Appl^{for Constr of Roads} was mailed to Doylestown Apr 17th. Abram K. Gother's Sec.
