The Supervisors of Halltown Twp held their meeting this day with all members present passed & paid the following bills amounting to 3058.24 Receipts amounted to 391.63. The Supervisors passed a resolution upon motion made by Paul Frankenfield and seconded by Elmer High to raise the P.E. Tax levy from .005 to .007. Tax Rate now is .007 on P.E. and a Per Capita tax of 5.00 in lieu of occupational tax. and is being advertised in The News-Herald. The 1959 budget was made up and a Budget Report sent to (Dept of Internal Affairs Harrisburg Pa) Mr Linus Tyson was appointed to serve as police in the Twp on a part time basis. Upon motion made by Elmer High and seconded by Paul Frankenfield. The Budget for 1959 is in the amount of \$86,039.44 to be finally adopted on Mar 7, 1959. Permits for peddling are being printed for the Policeman to hand out when requested at a cost of \$5.00 a permit. The meeting adjourned to meet on Feb 21 with a Bal in The Treasury of 9802.19. Rent Fund 4252.64 in S. R. or Total of 14054.83. The Board of Supervisors raised the pay for police man from \$1.50 to \$1.60 per hour of service and 1.00 per mile for use of car.
