The Supervisor of Hilltown Twp held their semi monthly meeting this day with all members present, passed + paid the following bills amounting to \$1447.22. Receipts amounted to 387.5. Balance in the Treas. as of Nov 2040.98 in Gate Fund and 18671.98 in Gen Fund or a total of 20712.96. Mr Cooney and his father Richard Cooney were present to discuss his protest and conditions of his Trailer Park. John Cooney then signed an application for permit for 1 yr for a Trailer Park now in existence, and received his permit at the sum of \$10.00. Marion Roshong and Mr + Mrs Monahan were present to discuss means to prohibit nuisance by a neighbor of too much junk and too many rats, and also of fire hazards on the neighbor's property. The County Aid + Pa Dept. of Highways forms were prepared and sent to W.M.H. Fell of the cost of Construction Roads in 1960. Cost was 32980.50 or cost per mile 9696.87. The Street Light Tax on 1/3 + B. G. was transcribed by the Sec. and turned over to the Tax Collector for collection. Trial Tax 861 - 953.92. L. H. Derstine was present + turned in 15.00 for permits and will take charge and collect money for a bad check rec. by the Treasurer on Nov 5 1960 amount \$20.00. The meeting adjourned to meet on Dec 3 1960 at 9 A.M.
