The Supervisors of Hilltown held their semi-monthly meeting this day with all members present. passed and paid the foregoing bills amounting to 2941.40 from Gen. Fund and 3415.93 S.F. or a Total of 6357.33. Balance in the Treasury at end of meeting was 2040.98 in State Fund and ^{in State Fund} 20079.25 or a Total of 22120.23. Wm Darrak presented the Plans for approval of Building ^{on} his farm which Mr George Rebellis a Registered Surveyor had tested the ^{plan on Sept 7} lot of said plan and G. Keit for downage etc and upon a motion by Mr Agin and seconded by Mr Hockman was approved & signed. Also by motion of the Board the Baptist Church Plan for enlarging their cemetery was approved & signed. A motion was made by Mr Agin and seconded by Mr Frankfield to direct their Solicitor to draft up 2 Ordinances to combat disorderly practices and littering in Hilltown Twp and have them published in the Paper to be adopted at the Dec 5 meeting. A motion was made to subscribe for the Bucks County News for the Supervisors. Sec of the Board. Sect of the Planning Comm. The zoning Officer Chairman of zoning Bd. of adjustments. The Auditor Tax Collector and the Assessor at cost of 24.00 per year. County Aid appls were sent to Bucks Co Commission for County aid on pipe. Cost of Pipes \$621.86 for 1959 + 1960 Pipes used for Construction.
