The Supervisors of Hilltown held their semi monthly meeting this day with 2 members present Mr Agin being absent. The foregoing bills were passed and paid amounting to \$759.67 in Ben Fund and \$4084. from State Fund a total expenditure of \$4843.67. Receipts amounted to \$44.00. Bal in The Treasury at close of meeting was \$4450.33 in The Gen Fund, and \$6814.47 in State Fund or a total of \$11264.80. A citizens committee of approx 20 Taxpayers were present to protest against the land fill and junk on the property of Paul Alderfer and were informed by The Board Chairman that steps would be taken to remedy their complaints in legal order. Dick McCoach was present for information of zoning ordinance. Mr James M Toessner, field Supervisor of The Bucks Co Board of Health was present and gave some interesting advice on the problems confronting Bucks County municipal problems. A letter was mailed on Aug 22 to inform The Penna Dept of Highways of right of way of Twp Rds namely 133 ft in width. The meeting adjourned to meet on Sept 3d. at 9 A.M. A subdivision plan was presented to The Supervisors by Charles Ingram and approved, and signed by The Supr. Abram R Gathers

Receipts amounted to \$16863.63 leaving a bal. in the Treasury of \$15981.25 in the Gen. Fund and \$8339.24 in State Fund. Total amt. in the Treas now is \$24320.49. Budd Mounce was present at the meeting to tender his resignation as a member of the Twp Industrial Committee, and was reluctantly accepted. Mr Ed Shuck, Sec. of the Planning Com. was also present to discuss matters pertinent to Planning for the Township. The board members resolved to forward a letter to Mr Mounce of appreciation of his services as a member of the Industrial Committee of the Township and a letter was sent to Mr Mounce thanking him for his services rendered while serving on said committee. The meeting adjourned to meet on Sept 17 at 9 A.M. at Twp Office.

Receipts amounted to \$97.96 - Bal in Treasury is \$14,959.71 in Gen Fund & \$4241.08 in S.F. or a total of \$19200.79. A letter was rec. by chairman of the Board from Clifford Dussell that he must ^{resign} from the Industrial Committee as he is moving out of Hilltown Twp in the near future. ^(Resignation was accepted and) A motion was made and seconded to request the Sec. to forward a letter, in behalf of the Board of Supervisors in thanks and appreciation for time and services rendered to the Twp. while serving on said committee. ^(and commendation of the Twp. Board) Such letter was mailed to Mr Dussell on Sept 20, 1960. Upon a motion & seconded the chairman appointed Albert Agin as ^{Police} supervisor to the Township Police, effective immediately. A going meeting to be held at the Twp Office on Sept 30 at 7.30 P.M. upon a petition by a taxpayer to combine & change zoning on 309 from Residential to Commercial, and is being advertised. The meeting adjourned to meet on Friday evening ^{Sept 30} a 7.30 P.M.
