A subdivision plan was presented for Charles Magee and was approved by the Supervisors. A motion was made & seconded to permit increase of signs from 1 sq ft to 3 sq ft in all residential districts. A motion was made & seconded to permit Mrs. Rachael Walker use fuse rope for agricultural purposes, and also to exonerate Mrs. Edith Dalem from paying tax. The Police were present and received copies Barricades, Blinkers & Flashers to be used in any emergency cases. All bills passed & paid amounted to \$2570.91 from Gen Fund and 1589.35 from State Fund a total Exp. of \$4160.26. Receipts amounted to 6891.86. The Bal in the Fund at close meeting 6887.86 + 30.00 Res. Aug 6 by mail of 30.00 or 6891.86. The meeting adjourned with a Bal in Gen Fund of 5163.00 and S.F. Bal of 10898.47 or a total of 16061.47.
