The Supervisors of Hilltown Twp held their semi monthly meeting this day with all members present. passed + paid the foregoing bills amounting to \$759.90. A motion was made and recorded by the Supr. to accept plans for tract No 2. subdivision presented by Mr Donald Barth. Mr Dick McCook was present as a representative for Robert Widdemeyer inquiring about his plans to build an addition to his house of 15 ft. leaving 5 ft to property line. To be held under advice until such time as he makes an appeal to zoning ordinance. Atty Ruth was present as a representative of Milbur Twp to inquire about making part or whole of 309. from 113 to Cherry Lane all commercial zone instead of residential as at present. Mr Tom Bassett, Representative of Road Machinery Co for the purpose of selling a snow plow and mounting for same. A snow plow mounting was purchased by the Supr. to be installed in Aug or Sept. for the price of \$758.50 including installation. Receipts amounted to \$5.00. Bal in the Gen Fund is \$1862.77 an Bal in S. F is 16846.63 or a total of \$18709.90 in Twp Treasury. The meeting adjourned to meet on July 2 at 9 AM.

F. or a total of 3343.37. leaving a Bal in the Gen Fund of 996.70 and in State Fund 12487.82 or a total of \$13484.52. Receipts amounted of 360.50. Mr Dugin made a motion, seconded by Mr Frankensfield to purchase from Mr Monroe 2 Guard Gate Baricades 2 with blinker Battery an 1 with red flag, also 6-18-18 flags for Highway safety. Herman Peters zoning Officer was present and submitted \$98.00 received for zoning book and building permits. The meeting adjourned to meet on July 16<sup>th</sup> at 9 A.M.

Motion were made by Paul Frankensfield and seconded by Elmer Hockman to propose a change of zoning the residential area east of 309 from residential to Highway Commercial, from Rt 428 813 to Highway Commercial.
