The Supervisors of Hilltown held their semi monthly meeting this day with all members present. passed & paid the foregoing bills amounting to \$4006.73 from New Fund and \$488.55 from State Fund, a total expenditure of \$4495.28. Receipts amounted to \$2568.73, leaving a bal. in the New Fund of \$5993.36 and in State Fund of \$97.49. or a total of \$6090.85 in the Treasury. A new truck purchased from Ebert motor co was delivered recently and Mr Paul Ebert was present at the meeting to enact a new truck title. Payment on truck was withheld at present to be paid in 30 or 60 days from this date. Mr Herman Peters the Twp. zoning officer was present and turned in to the sec. \$287.00. for Permits for Const. & zoning books and 2 to Desline turned in \$10.00 for soliciting Permits. A Taxpayer for school Road was present to discuss junk Dealers Ordinance & license fee. No decision was determined, but he was advised to clean up or face the possibility of paying for a junk Dealers License. The meeting adjourned to meet on May 21, 1960.
