The Supervisors of Helltown Twp held their semi monthly meeting this day with all members present, passed & paid the following bills amounting to \$1422.53. Receipts amounted to \$750.18, leaving a Bal in the Gen Fund of \$15,688.75 and 2, F Bal of \$208,42. or a total of \$208,971.7. Mr. Moore was present at the meeting to inquire trailers parked on his property. He was requested by a motion made by Mr. Agin and seconded by Mr. Frankenfield to have removed all trailers on his property by Apr. 1, 1960. The peddling ordinance was discussed as to have all solicitation on obtaining a license to furnish a photograph of the one receiving a peddling license. No further action was taken. Mr. Herman Peters, zoning officer was present and turned in zoning permits in amount of \$95.00. The meeting adjourned to meet on Feb 21 at 9 A.M. 1960 Budget advised on Feb 10, 1960. Abraham K. Mr. Hermit & Mr. Haupt were present to discuss the feasibility of creating a subdivision on Mill Rd. and a meeting was held on Tuesday night following and it was said by the solicitor the supervisors had no right to sign Hermit's plan since zoning has been invoked, and now leave it up to Atty Haupt.

The Supervisors held their semi-monthly meeting this day with all members present, passed & paid the following bills amounting to \$1229.20. Receipts amount to \$58.50, leaving a Bal in the Gen Fund of \$13,319.23 and \$208,42 in 2 F. Total of \$18,537.65 in the Treasury. Mr. Herman Peters, zoning officer was present and turned over to the treasurer his receipts rec. from zoning permits & zoning books. Upon motion by Mr. Agin and seconded by Mr. Hockman the subdivision plans from Mr. Kenneth Green with subdivisions on Mill rd and the Harlow tract on Callowhill Rd. be adopted, and were finally adopted this day. A motion was made by Mr. Agin and seconded by Mr. Frankenfield to appoint Ferd Spangler of Helltown as zoning adjustment committee man to succeed Mr. Ernest Sinyge who presented to the board his resignation as zoning adjustment Board member, to take effect immediately. The resignation was accepted and Mr. Spangler appointed for the unexpired term of Mr. Sinyge and Mr. Agin was requested to inform them of their transaction. Bids for purchase of a Tug Truck were drawn up to be advertised in the News Herald by Mr. Agin. Bids to be let on Mar 19, 1960. and 2 one bids also to be let on Mar 19, 1960
