The Supervisor of Hilltown held their semi monthly meeting with all members present passed and paid the following bills amounting to \$19,272.30. Receipts amounted to \$20,910.00. The balance in Town Treasury of \$16,361.18 and State Fund of \$20,842.00 a Total Cash of \$21,569.60. Herman Peters Joking Office was present and turned over to the Board \$4,000 for 2 Bdgl. permits Mr Paul Alderfer was present and upon a vote of 2 Apts. Mr Agin abstained from voting. received a Junk Dealer's license. Upon motion by Mr Agin and seconded by Mr Hockman the chairman appointed Lloyd Goder as a member of the planning commission for 5 yrs to 1965, Mr Harold Moyer serves to 1964 John Alderfer to 1963, Ed Schenk to 1962 and Carl Bruner to 1961. Martin's Police was present and proposed change of an ordinance for reckless driving and speeding on ^{the} highways. The auditor's report is met on Tuesday evening at the Town Office to conclude the 1959 audit. The Supervisor discussed the intention of buying a new dump truck to be delivered before spring.
