The Board of Supervisors of Helltown Township held their semi-monthly meeting this day with all members present. Mr. Frankenfeld presiding.

The minutes of the previous meeting was read and approved. Bills amounting to \$4918.93 from the Township fund and \$4825.13 from the state funds was approved & paid. Receipts was \$9,245.38 in Tax funds, leaving a balance in the Tax funds of \$21,557.34 and \$12,254.50 in State funds.

A Resolution was passed transferring \$10,000.00 from Construction to maintenance in the state funds, also a resolution transferring \$5,000.00 from construction to maintenance in the tax funds.

The report from the zoning officer was read and approved, his report showed a steady building program for the first 6 months of 1961.

The Tax Collector, Mr. Smith, gave his report showing a steady collection program under way.

Mrs. Morahan, one of the top taxpayers attended the meeting requesting some action on the poorly erected building of her neighbor. Mrs. Morahan, claimed the building was a fire hazard and wanted something done before it became a hazard to the whole neighborhood. Mr. Frankenfeld, instructed Mr. Lynn to contact the Heri Refractor, Fire Co and have them check inspect said property.

The matter of Police was discussed with still no solution to the proper protection in the township.

There being no further business, meeting adjourned to meet Aug 19 - 1961
