The Regular - Semi-Monthly Meeting of the Hilltown Township Board of Supervisors was held this day - Mr. Frankfield, the Chairman - Presiding. The minutes of the previous meeting were read and approved. Bills amounting to \$2,729.93 from the Township funds and \$775.24 from the State funds were read & approved for payment. The Road Profile for the "Evergreen Estates", was presented, discussed with Mr. Frankfield, the Roadmaster who will give it further study and report on it at a later date.

Messrs Mounce, Derstine, Schell, Peters, H. Derstine, <sup>Rosenberger</sup> were present. Mr. Mounce, questioning the status of Mr. Derstine as a policeman, the board giving no decision at this time. Mr. H. Derstine and Mr. Schell made a complaint that the trucks hauling trash to the landfill are losing some of this trash along the roads because ~~the~~ some of these trucks are not covered, attention to Mr. Alderfer was to be forwarded as to these complaints.

Mr. Rosenberger, forwarded his Tax Collectors Report, this report showing almost 80% of taxes collected to date.

The Zoning officer's Mr. Peters Report was read showing an increase in construction over 1961 for the month.

Mr. Agin, reported his prices for uniforms & equipment for the C.D. Police. - No action.

General Discussion on Problems of C.D., Radio, Roads etc. was held with no decisions at this time there being no further business meeting adjourned at 1:15 P.M. to meet Nov 17-1962 at the Township Office.
