Mr Frankfield requested we raise the hourly pay of Mr Darwin Bieby to that of an operator, Mr Agin, protested this, claiming the man isn't the same caliber as our operators, after a lengthy discussion Mr Frankfield moved to increase his pay from \$1.60 to \$1.70, with a second from Mr Packman, motion carried.
