The minutes from the previous meeting were read and approved. Bills amounting to \$1684.55 from the township funds and \$1783.70 from the Store Funds were read and approved. The Socy. Trus's Financial Report was read & accepted. The Board approved the purchase of a duplicating machine and instructed Mr. Agin to purchase same. Mr. H. Franklin Moore, Mr. Valentine Lee from the School Board and Mr. Richard Coven, the Township Engineer along with the Board reviewed the plans for the proposed John Grasse school being erected along "Reicherts Road". The plans submitted to the school Board were not clear as to the curbs and sidewalks. Mr. Lee & Mr. Coven to get together at the site and make a decision. Reports from the Police, Zoning officer, Tax Collector were reviewed & accepted. Bids for a 1962 Dump Truck were presented and opened as follows. EBERT Motor Co. - 1-1962 International W-TAG Dump Truck Equipment per Spec's and a New "Root Spring" snow Plow with quick Detachable Hasting H-Tch with Monarch Electric Hydraulic Pump. \$7,750.00 Trade in allowance for 1954 International Dump Truck - \$1,250.00 or a net \$6,500.00. There being no other bids, order for the new truck was placed with Ebert Motor Co with Delivery to be made on or about the 1st of Aug-1962. Mr. Paul Hartman, a taxpayer on Rt 313 attended the meeting requesting the Board do something about ticks. He was advised that the Board wasn't in a position to control ticks. There being no further ~~business~~ ^{business} meeting adjourned to meet on June 16th. 1962 at the Township office.
