The Semi-Monthly meeting of the Hilltown Township Board of Supervisors was held this day - Mr. Frankfield Presiding. Those Present were Supervisors - Agor, Hockman, Frankfield. Taxpayer - Mrs. Brenner,

The minutes of the previous meeting were read - approved. Bills amounting to \$1319.98 from the general fund were read - motion by Hockman - Seconded Frankfield - Bills were authorized for payment.

The Secretary reported on costs for the construction period as follows: Twp Road 417 - which was 0.9 (tenths of a mile) cost \$17,599.42 - Twp Road 346 - (Telegraph Rd) was constructed at a cost of \$15,640.31 - Cost of this construction was \$33,199.73 or \$18,444.30 per mile or \$1.74 1/2 sq yd.

Mrs. Brenner presented a petition against the construction of Skunk Hollow Road, also on this petition was signed for the construction. Mr. Agor, was instructed by the board to take the petition to the solicitor for his decision.

Mr. GEO McSHANE - quoted a figure of \$1181.10 for 3 C.B. Truck Radios & 1 Base Station radio, after much discussion, this was tabled until a further date.

A discussion on the full-time police force was held, again no decision from the board.

There being no further business, meeting adjourned at 2:15 P.M. to meet Dec 7-1963. at 9:00 at the Twp office
