The Meeting of the Hilltown Township Board of Supervisors was held this day, Mr. Frankfield - Presiding. Those Present were Supervisors - Frankfield - Heckman - Police Officers - Tyson - Derstine, Zoning Officer - Peters, Tax Collector - Rosenberger, Tax Coordinator - Smithers, - Representative from "Ken Kratz Real Estate Office."

The Minutes of the Previous Meeting were Read & approved. Bills amounting to \$9643.09 from the State funds, \$977.14 from General funds were Read and approved for payment.

The Secretary requested permission to purchase stamps and office supplies - "Request Granted."

Reports from Officers - Tyson - & Derstine were Read and with no particular Police Problems at present, Reports accepted.

A letter from the Hilltown Township Board of <sup>Civic</sup> Associates was Read, requesting the immediate dismissal of officer Derstine from the Police force, because of his personal Court conviction.

Mr. Heckman expressed an answer would be in order - no further action until the full Board could review this with their attorney.

A Representative of the "Ken Kratz Real Estate Office," requested a zoning variance - This was turned over to Mr. Peters & Bd of Adjustment.

Permission was granted to Mr. Snyder to replace a trailer home with a house on a private Road with no Township Affiliation.

Mr. Peters - Zoning Report showed an increase of 8 Bldgs for the Month of June, a total Collection of Permits totaling \$212.00

Mr. Rosenberger's Tax Collector Report showed his first Collection for 1963 to be \$12,568.01 - 1961-62 Delinquent 380.19.

Mr. Smithers - Reported - 218 - Tangles - Deleted for the Duplicate & 478 - Added.
