Minutes from the Previous Meeting were Read and approved. The Treasurers Report was Read & Approved. Bills amounting to \$3839.08 were Read & ordered Paid.

Mr. Rosenberger, presented his Exoneration list for the month of March - amounting to \$65.00 - Motion by Frankenkfield seconded by Hockman - said list to be accepted & added to the Exoneration Book.
