The Regular semi-monthly meeting of the Hilltown Township Board of Supervisors was held this day, Mrs. Frankfield Presiding. Those attending were Supervisors Agard, Heckman & Frankfield. Mr. James Smithus, minutes from the previous meeting were read and approved.

Bills amounting to \$3647.91 from the general fund were read and approved for payment.

A discussion on the proposed construction program for 1963-1964 was had. Motion by Agard, seconded Heckman, that roads to be constructed in the future have a minimum cart-way of 18 ft instead of 16 ft with a 5 ft shoulder, motion carried unanimously. The Roads to be built in the 1963 Budget are the widening of "Reebut Road" from Green St to Diamond St. This program is to take the school buses that will be using the road for the new John Horse School; also the continuing of Reebut Road (a new construction of 3/4 of a mile) from Diamond St to the next intersection, and the 8/10ths of a mile of Telegraph Road from Rt 113 thru to the next intersection. Mrs. Frankfield, also stated he proposed to surface treat - about 6 miles of road this year.

The Board also proposes to build only 1 pc of Road for 1964, that being Skunk Hollow Road (1/2 mile long) at an approx. cost of \$30,000.00.

Mr. Smithus, requested the board to show the cost of Tax Co-Ordinator for the Per-Capita Tax. Cost to be approx. \$500.00 a year. Motion by Heckman, seconded Agard, motion carried. Resolution to be drawn up & presented to Smithus & Tax Collector.

There being no further business, meeting adjourned to meet. Feb-2-1963.
